

CBI is an advisor to Cornucopias, a massive blockchainbased game

CRYPTO BLOCKCHAIN INDUSTRIES (CBI, Euronext Growth Paris: FR0014007LWO, ALCBI) announces that it is an advisor to Cornucopias. This agreement is part of Alphaverse's strategy to assist a large number of virtual world projects.

"The Island" by Cornucopias is a blockchain-based game that features Build-To-Earn and Learn-To-Earn* functionalities, allowing players to be rewarded with and/or own lands, properties, and other NFT assets with ingame value while playing games in a fun and secure metaverse.

AlphaVerse, CBI's blockchain-based virtual world (metaverse), is currently in the opening phase for testers. The goal of AlphaVerse is to create a central hub on the blockchain that connects multiple metaverses to offer the widest possible experience. AlphaVerse is developing different universes, some of which use third-party brands. AlphaVerse is an open world that does not require users to own cryptocurrencies to open their account and visit the virtual world. Some experiences are also accessible with traditional currencies, with cryptocurrencies only required when NFTs are bought or traded.

CBI already holds 1.0% of Cornucopias Technology PTE Ltd, the company that owns the Cornucopias universe, as well as 0.5% of COPI tokens (19.2 million COPI tokens), which are valued at over USD 0.8 million.

To strengthen these strategic ties, Cornucopias and CBI have agreed to a two-year initial agreement for mutual recruitment and revenue sharing. Cornucopias will be able to promote the AlphaVerse universe and will receive 10% of the revenue generated by AlphaVerse from members of the Cornucopias community. This agreement is reciprocal, and the same provisions apply in favor of AlphaVerse, which will receive 10% of the revenue generated by Cornucopias from the AlphaVerse community.
